

Merrifield Display Village Scan & Win Competition

Terms & Conditions

In these terms and conditions these defined terms have the following meanings:

Adjudicator	An employee or agent of the Promotor who has been appointed by the Promotor to judge the Merrifield Display Village Scan & Win Competition.
Eligible Entrant	An entrant participating in the Merrifield Display Village Scan & Win Competition who, at the sole discretion of the Promotor and the Adjudicator, satisfies the requirements of PART A of these terms and conditions.
Eligible Entries	An entry by an Eligible Entrant.
Eligible Prize Winner	An Eligible Entrant entitled to receive a Prize in accordance with these terms and conditions.
First tier prize	Visit 10 builders for a chance to win a \$1000 Visa gift card.
Second tier prizes	Visit 7 builders for a chance to win one of two \$500 Visa gift cards.
Third tier prizes	Visit 4 builders for a chance to win one of four \$100 Visa gift cards.
Merrifield Display Village Scan & Win Competition	This completion governed by the terms and conditions set out herein.
Prize	A collective reference to the First tier prize, Second tier prizes and Third tier prizes.
Promotion Period	The period commencing at 11am on Saturday 27/03/2021 and ending Sunday 23/5/2021 at 5pm.
Promotor	Ascotown Pastoral Company P/L (ACN 116 959 365)

PART A – Entry into the Promotion

1. To validly enter, an Eligible Entrant must, during the Promotion Period:
 - a. Download Merrifield App;
 - b. Scan QR codes at each builder in the Merrifield display village (in Scan and Win tab of the My Merrifield app) and log in to access the promotion;
 - c. The prizes mechanics are:
 - Visit 4 builders for a chance to win one of four \$100 Visa gift cards.

- Visit 7 builders for a chance to win one of two \$500 Visa gift cards.
 - Visit 10 builders for a chance to win a \$1000 Visa gift card.
- d. an Eligible Entrant is permitted to 1 entry per log in/registration to My Merrifield app;
- e. offensive content as deemed by the Promotor (in its sole discretion) will not be permitted as an entry;
- f. the time of entry will be deemed to be the time it is received by the Promoter; and
- g. satisfy any other requirement of the Promotor.
2. By participating in the Merrifield Display Village Scan & Win Competition an Eligible Entrant confirms its acceptance to the terms and conditions set out herein.

Judging of Entries

3. Judging will be conducted by the Adjudicator (at the Adjudicator's sole discretion) and will take place on Monday 24 May 2021.
4. Eligible Entries will be judged based on the number of builders that were visited based on the tiers of prizes.
5. The Adjudicator's decision will be final and no correspondence will be entered into.
6. Any entry that is made on behalf of an Entrant by a third party will be invalid.
7. Each valid entrant who has entered the competition over the duration of the promotional period will be entered into the draw. The first 4 valid entrants will be drawn at random to become the third tier prize winners (win one of four \$100 Visa gift cards), the first 2 valid entrants will be drawn at random to become the second tier prize winners (win one of two \$500 Visa gift cards) and first valid entrant will be drawn at random to become the first tier prize winner (win a \$1000 Visa gift card) - any ineligible or incomplete entries drawn will be discarded and a new entrant draw until all prizes have been allocated.

The Prizes

8. The Eligible Entrant who's Entry is adjudged to visit 10 builders will receive the First Tier Prize. The Eligible Entrant who's Entry is adjudged to visit 7 builders will receive the Second Tier Prizes.
The Eligible Entrant who's Entry is adjudged to visit 4 builders will receive the Third Tier Prizes.
9. No compensation will be payable if an Eligible Prize Winner is unable to receive, redeem or use the relevant Prize.
10. Prizes are not exchangeable or redeemable for cash or other goods or services and gift vouchers for first, second and third prizes and the Visa gift cards will be provided by Merrifield.

11. A Prize cannot be transferred to any other person without the express written consent of the Promoter.
12. If the Prize (or any part of the Prize) is unavailable, the Promoter, in its discretion, reserves the right to substitute the Prize (or that part of the Prize) with a Prize to the equal value and/or specification.

Promotor Rights and Limit of Liability

13. The Promotor is not responsible for any lost, late or misdirected entries;
14. The Promotor reserves the right, at any time, to verify the validity of entries and Eligible Entrants (including an entrant's identity, age and place of residence) and to disqualify any entrant who tampers with the entry process. Failure by the Promotor to enforce any of its rights at any stage does not constitute a waiver of those rights
15. The Promotor reserves the right to at any time amend, vary or change (without reference or notice to an Eligible Entrant or any other party):
 - a. The Prize;
 - b. Any term or condition contained in these terms and conditions.
16. Failure by the Promotor to enforce any of its rights at any time does not constitute a waiver of those rights.
17. Except for any liability that cannot be excluded by law, the Promotor (including the Adjudicator, its officers, employees and agents) excludes all:
 - a. Statutory liability;
 - b. Representations, conditions and warranties implied by custom, the general law or statute;
 - c. liability for negligence, any personal injury and any loss or damage whether direct, indirect, special or consequential (including economic loss, loss of revenue, loss of opportunity, loss of goodwill), arising in any way out of the Merrifield Display Village Scan & Win Competition, including, but not limited to:
 - (i) any variation in value in the event that Prizes are replaced in accordance with these terms and conditions;
 - (ii) any tax liability incurred by an Eligible Entrant; or
 - (iii) use of the Prizes.

Notification of the winners

18. The winners of the First, Second and Third Tier Prizes will be notified by the Promotor by 5pm, Tuesday 25 May 2021. Instructions for Prize redemption will be provided by the Promotor thereafter.
